1. The Sunil Smriti Rural Municipality Office of Rural Municipal Executive Sulichur, Rolpa invites sealed bids from eligible bidders for the construction of **Gaunpalika stariya khelmadaan Nirman Ward-4, Chirne** under National Competitive Bidding procedures.

5. Sealed bids must be submitted to the Sunil Smriti Rural Municipality Office of Rural Municipal Executive Sulichur, Rolpa by hand/courier before 2076/02/31 12:00 hrs. Bids received after this deadline will be rejected.
6. Sealed bids must be valid for a period of 90 (Ninety) days after bid opening and must be accompanied by a bid security amount to a minimum of **NRs 90,000.00 (Nepalese Rupees Ninety Thousand Only.)**, which shall be valid for 30 days beyond the validity period of the bid (i.e. not less than 120 days after last date of bid submission).
7. Sealed bids shall be opened in the presence of Bidders' representatives who choose to attend on 2076/02/31 14:00 hrs Sharp at Sunil Smriti Rural Municipality Office of Rural Municipal Executive Sulichur, Rolpa.
